

7. Discussion on Watauga Improving Neighborhoods Program revitalization efforts

Chairperson Reyna mentioned that the Spring Blitz will be April 8-9, 2016. Volunteers are needed and interested parties can apply through the 6Stones website. We have eight (8) properties that qualify at this time.

Randy Richards discussed the funding available. Approximately \$13,000 has been expended for the Fall Blitz Homes. It is anticipated that several homes can be included in the Spring Blitz with the remaining funding. Rodney from 6Stones will research this and will have a better idea after the scope of work

has been completed for homes. Randy mentioned that more volunteers are needed.

Rick DeVoss mentioned that many times applicants list interior work and there was discussion on possibly changing the application to ensure work is listed regarding outdoor projects for homes. It was discussed that there are limitations to interior work, but listing the interior work may help the homeowner qualify for another program such as HOME.

Chairperson Reyna mentioned all properties under item #6 new business have been rated and qualify for the program. In addition, the following properties have been rated and qualify: 6544 High Meadow Court, 6288 Stardust Drive, and 6032 Whispering.
